1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Shankarrao Patil Mahavidyalaya, Bhoom established in 1984 is run by Vidya Vikas Mandal, Pathrud.It is a center of learning for the students to rural villages of Bhoom taluka in Osmanabad District. This taluka is one of the most socio- economically, educationally and draught affected taluka in Osmanabad district as per the survey of Central Government's 'NITI Ayog' (National Institution for Transforming India). Our college is a grand- in- aid college affiliated to Dr. Babasaheb Ambedkar Marathwada University Aurangabad. It has 2(F) and 12(b)status of UGC New Delhi. The college has located in the hilly area. college offers UGC Programmes /Courses such as BA in Marathi, Hindi, English, History, Political Science, Economics and Sociology.B.Sc.in Botany, Chemistry, Zoology, Physics, Mathematics and also B.Com. program. Total number of teaching staff is 26 & 01 librarian for the academic year 2022-2023. The total strength of the student is 766 for the academic year 2022-2023. The college has NSS units of 250 students. This NSS units have been conducting and arranging constructive social activities which helps to make awareness about social responsibility and social contribution of the students. These units are actively involved in the community-based activities.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

Shankarrao Patil Mahavidyalaya, Bhoom is affiliated to Dr. Babasaheb Ambedkar Marathwada University, Aurangabad. So, we follow the curriculum prescribed by the University. We run B.A. B.Com. B.Sc. programs. Elective system is applied for 2nd year, 3rd year B.A. B Sc. whereas CBCS system is followed for B.Com. and first year B.A.& B.Sc. For these courses' curriculum is prescribed by the University. The institution ensures an effective curriculum delivery through a well -planned and documented process like preparation of academic calendar, department time table, annual teaching plan etc. Teachers use various ICT tools to deliver the curriculum, as well. The academic calendar is prepared taking in to consideration the declared calendar of the affiliating university. This helps the institution to adhere to the schedule of the calendar effectively. College prepares own academic calendar according to university schedule, for internal assessment and evaluation, test and tutorials are organized. As the university follows the semester systems tests and tutorials are planned accordingly.

All staff is well qualified and competent. Some of the teachers work on various committees of University and are engaged in paper setting work. Teachers are relieved for paper assessment to DCAS (District Centre Assessment System). For 3rd year of BA students have to complete a project of 100 marks for B.Sc. and B.Com. practical's are part of program. In the beginning of every academic year, IQAC allots the work of various committees such as preparation of academic calendar, workload and curriculum completion follow up. Annual teaching plan is compulsory for all departments.

The college integrates cross- cutting issues relevant to professional Ethics, Gender, Human values, environment and sustainability into the curriculum. It organizes other extracurricular activities relevant to cross cutting issues to integrate them into the curriculum as well. The institute has a systematic procedure to receive year-wise feedback from Students, Teachers and Alumni. The feedback is collected from the stakeholders, the feedback is analyzed and the action taken report is made available on the institutional website.

Teaching-learning and Evaluation

Teaching learning and evaluation are major areas of any institute. The college admits student from varied socioeconomic backgrounds. The students are counseled, guided and oriented at the time of admission to make them aware about the course, mode of internal assessment, external assessment, curricular and co- curricular activities, rules and regulations of the institution as well as facilities available in the college. This information is also published in the college prospectus which is provided to the students before the beginning of the academic sessions.

Department wise publication of wall papers, organization of competitions, literary associations, quiz competitions record is maintained. Record of practical's from science department, study tour from History, sociology departments and industrial visit of commerce faculty are recorded. IQAC ensures the use of student-centric methods in teaching-learning process.

IQAC promotes the use of ICT based teaching as it enhances the teaching learning process.

In terms of continuous internal evaluation our college has its own effective continuous internal evaluation system. It is transparent and robust in terms of frequency and variety. The college has also a mechanism to deal with examination related grievances which is transparent, time bound and efficient.Time table, notice is provided and are mentioned and shared to student's WhatsApp group in detail.

The Institution has prepared program outcomes for B.A., B.Sc. and B.Com. programmes. Programme and course outcomes by NAAC have been designed for students and other stakeholders. They aim at making the students ready and equipped with knowledge and sets required for future.

Evaluation outcomes serves the institution as an effective tool for introspection and improvement. Students are guided with required mentoring so they achieve the desired outcomes.

Research, Innovations and Extension

Research innovations and extension includes all research activities projects, facilities, guides and funds generated for these activities. The research committee monitors research activities in the college. Innovative ideas from staff and students are encouraged, Institute provides all necessary infrastructure and facilities for research work. The authorities regulatory got follow-up of research activities in college. It is observed that teaching faculty pursues research work continuously.

As on today 44.44% (12) of the staff is Ph.D. and remaining 08 are doing their research work. Proposals are forwarded to University and UGC by IQAC for funds to organize seminar, conferences, workshops and research projects. One minor research Project is sanctioned by parent University in zoology subject.

The extension activities are carried out to connect the Higher education Institution with the society. The extension activities are carried out online.

In this period, we also organized seminars and awareness programs in online mode using Google meet and zoom platform.

In college campus also we organize various extension activities like International Yoga Day, environment awareness programs, Personality development programmes. World AID's awareness day was celebrated. The NSS unit of the college organized blood donation and health checkup camp with the collaboration of Rural Hospital Bhoom, and Bhagwant Blood Bank Barshi. The college has MOU with Nirbhya Help Line which arranges defense programmee to the girl students. The MOU has established with Shree computers for the maintenance of computer and other computer related accessories. The college organizes a number of extension activities to promote and sensitize the students towards community needs. The students of our college actively participate in social service activities leading to their development. The college has 09 functional MOU with various agencies, industries, and organization. Study tour, field visit, training program and other collaborative activities are carried out with this MOU.

Infrastructure and Learning Resources

Shankarrao Patil Mahavidyalay's campus spreads over 15,100 Sqmt is wholly self- contained Campus Comprising of 12 classrooms, 4 labs, 27 computers. Institute have LCD projector for teaching and learning process. For advance teaching and learning college has ICT hall with smart board. Institution Library has a reading room for college students and faculties. For practical based learning zoology and botany departments have museums with preserved rare species of animals and plants respectively.

Institute has provided two ramps for physically handicapped students. Institute's computer lab is well versed with internet facilities. It has a separate parking area for all students and faculties. Institute also provides clean

and pure drinking water. For power back-up in administration section college has an inverter. The college has a movable LCD projector which is used commonly in the college. IT helps to make teaching learning process more effectively. It encourages students to listen, learn and perform Group discussions and to enhance their interview skills. The institute has specious Library with reference and text books, journals, magazines and newspapers etc.

The institution utilized its resources to provide an environment to its students where they are encouraged to pamper in sports and extra-curricular activities, which ensures a holistic development and all rounded personality development. Students who shows extra ordinary skills in different sports are provided with systematic training and encouragement by the institution. These students are selected through selection trials. They are encouraged and trained to participate in various levels of competition including inter College events, inter University events. Yoga Day programme was conducted for the faculty and students by expert yoga trainers. College believes in all round development of its students. It constantly encourages them to take part in extra-curricular activities, every year the college conducts cultural programs to make this happen.

Student Support and Progression

The college has initiated capability enhancement and development schemes such as soft skills development language and communication skills Development through various short-term courses and activities.

Separate scholarship section keeps records and communicates updates to authority's. Category wise reservation and gender ratio is maintained in selection of beneficiary students. Life skills (Yoga, physical fitness, health and hygiene) and ICT/ computing skills through various programs and initiatives. Students have been benefited from capability enhancement and development schemes. The institution has a transparent mechanism for timely redressal of student grievances including sexual harassment and ragging cases. Career guidance counselling is provided to students. Code of conduct is fixed for all stakeholders. The Code of conducts are displayed on College website. Health checkup camp is organized for students, blood group checking and HB detection camp for girl students. Grievance redressal cell and anti-ragging committees are working for Student welfare.

Department of sport and physical education encourages student participation in ICT and IUT competition. Every year students participate in ICT, IUT tournament and get medals and certificates. These students are facilitated by college.

A student team is forwarded to University to participate in Yuvak Mahotsav. Students representation in college committee is made compulsory. CDC and IQAC has one representative. Literary Association, Science forum, Social science forum have student's representation. Alumni Association contributes significantly to the development of the Institution. Alumni meet is organized in college and their suggestion are taken into consideration.

Governance, Leadership and Management

The governance of the institution has been reflective of effective leadership in tune with the vision and mission statement of the institution. This criterion is meant for administration, leadership and management of the institution.

The management always encourages the involvement of the staff in the quality assurance, enhancement and development activities of the college by being members of committees such as IQAC, CDC, Staff council as HODs or as a coordinator of cells and student's council. It has a well-established system of effective practice of decentralization and participative management. All academics and administrative work is divided and bifurcated in to various sections and departments as a part of decentralization policy.

A perspective plan is prepared for five years taking ideas of all stakeholders into consideration. For transparency and decentralization in the institutes the college has various committees.

The institute has effective welfare measures for teaching and non-teaching staff. The higher education department and the college management gives sufficient freedom to the principal, who is the academic head of the institution to function in order to fulfill the vision and mission of the Institution. Academic responsibilities are fairly divided among all the staff members. Administrative powers and responsibilities are delegated to teachers on the basis of their competence, commitment and aptitude to meet the institutional objectives. For smooth Sailing of all work the responsibilities are divided basically into two wings as academic and administrative. Teaching- staff is engaged in academic while non-teaching staff in administrative work. After management of the institute, authority comes to college Development committee, and Internal Quality Assurance Cell. The principal, office superintendent, IQAC coordinator, Chairman of committees and the head of the departments shoulder respective responsibility.

Teaching and non-teaching staff is relieved from duties to attend seminars, conferences, workshops and training program as a professional development and career advancement. All departments are encouraged to organize seminar, quiz competition, conferences every year. Self-appraisal form from staff are collected every year and analyzed by the committee. IQAC looks after the academic excellence. IQAC is composed as per the guidelines of NAAC.

Institutional Values and Best Practices

Institutional values and best practice include all activities in the campus for overall holistic and sustainable development of the institute along with the academic excellence. It provides the facilities such as safety and security, counseling and a common room. Institutional preparedness for NEP

1. Multidisciplinary/interdisciplinary:

Shankarrao Patil Mahavidyalaya, Bhoom established in 1984 with BA and BCom programs were started to avail multi-disciplinary higher education to eligible students. In 2004 science stream was introduced.

	Students can opt BA or BCom after studying 12th science, in that case they are admitted to multi- disciplinary/Inter- disciplinary programs and bridge course. All UG programs have University curriculum. Our Institute is affiliated to Dr. Babasaheb Ambedkar Marathwada University, Aurangabad. So it strictly follows the curriculum and academic calendar prepared by home University. BA and BSc have elective mechanism while BCom have CBCS mechanism. At university level commerce, science, arts are individual faculties. TY BA students have a paper for project work. Conferences and seminars are organized. Students and teachers of all disciplines take interest in Inter- disciplinary research.
2. Academic bank of credits (ABC):	As our Institute is affiliated to Dr. Babasaheb Ambedkar Marathwada University, we strictly follow University curriculum and examination patterns. College faculties are involved in design of curriculum, setting of question paper at college level. The faculty of college is also involved in invigilation and assessment work. We have our own board of studies at college level where faculties design the curriculum and question papers for continuous Internal Evaluation. The institute has an experienced staff for Academic Bank of Credits (ABC), as a part of preparedness for New Education policy-2020 in the coming days.
3. Skill development:	The institute along with the traditional education offered by University, offers skill courses to enable students to seek employment after graduation. Today we have some certificate courses provide to students. These certificate courses go along with degree program at UG level. Students get employed in one or another firm. Majority of the student get jobs or they choose private sector or start their own entrepreneurs. Students undertake at least one certificate or skill courses so as to maintain employability and inter disciplinary approach. Students doing accounting and taxation get jobs in banks, credit society, entrepreneurs and companies. Commerce students got tally knowledge and C- language, certificate course go along with University program to aware students about professional ethics, human values, these courses are conducted department wise. All departments have liberty to design the curriculum and time table of the concerned value-added course.

4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	The institute has a strategy to integrate Indian knowledge system, Indian language and culture. Cultural programs, events, ceremonies days and festivals are celebrated by cultural department and NSS department. Marathi, Hindi and English department celebrate the days accordingly. Marathi day on 27th February, Hindi day on 14th September and English day on 23rd April every year. Current affairs are discussed poetry recitation, elocution competitions are organized and also focus on socio- cultral issues. The curriculum contains grammar of the language and literature of the era. Marathi, Hindi and English language are taught in the same language whereas commerce and Science are taught in English medium where as social science in Marathi. For the sake of understanding of student's bilingual method is used. Tribal languages are found in some historical monuments and documents. Indian arts, traditions and culture are taught in History subject. IT infrastructure and ICT enabled classrooms are provided to teachers for effective curriculum delivery.
5. Focus on Outcome based education (OBE):	The Institute aims to creative learning among students in order to boost their employment prospects. The institute looks for the outcome of education through alumni. Alumni of the college are working in various fields. Alumni forward their feedback which is taken into consideration by the institute. Course Curriculum is design by the University updates in curriculum for outcome-based education is forwarded to University through BOS members. Alumni meet and parent meet organized to discuss about outcome-based education. Curriculum is not designed by Institute as college is affiliated to Dr. Babasaheb Ambedkar Marathwada University. Field visit and project work help student to develop their outlook. The institution has adopted the CBCS pattern signed by Dr. Babasaheb Ambedkar Marathwada University as one of the initiatives for the effective implementation of outcome based education.
6. Distance education/online education:	The institute have smart classroom to offer online teaching, because of covide-19 background. Institution introduce online education for the students through online mode using zoom, Webex, Google Meet platform during the Covid-19 pandemic.

1.1 Curricular Planning and Implementation

1.1.1 The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

Response:

Every year, the principal, IQAC and HODs prepare an academic calendar, specifying the significant curricular and co-curricular activities with dates to ensure proper teaching- learning process and continuous evaluation and effective implementation and delivery of curriculum in each academic year. The college runs B.A., B.Com., B.Sc. as the main programme and certificate courses. The various committees are constituted at the first meeting. The general meeting is conducted for early planning of curricular and co-curricular activities. The departmental meetings are held at the commencement of the academic year to assign workload to the individual teachers. The distribution of papers is based on individual interest and their specialization. After distribution of time table, work load and papers, each teacher prepares teaching plan for the smooth functioning. In teaching plan, the focus is on allotted syllabus and its completion in stipulated time. Each teacher submits annual teaching plan to the principal either directly or through the head of the department.

Time table is finalized at the institutional and departmental level. The streamwise time table committee designs the time table for arts, commerce and science stream. The head of the respective departments finalize the departmental time- table in consultation with their colleagues. The principal, head of the department and teachers have well co-ordination regarding implementation of curriculum. The teachers are always encouraged and motivated by the principal for constructive classroom interaction. The teaching-learning and evolution process includes presentation assignments, tests, tutorials, study-tour, mid-term examination, course-wise project work, students' centric workshop. Teachers are also asked to prepare ICT based teaching. The curriculum is effectively implemented by the different teaching techniques. E-Learning sources, reference books and periodicals are referred and made available to the teacher and students. The department organizes guest lectures for the skill development of students. Stakeholders are regularly motivated for fair and smooth implementation of curricular and co-curricular activities.

Based on the university academic calendar Institute prepare Academic calendar containing the relevant information regarding teaching learning schedule, events to be organized, dates of internal examination, semester examination etc. With the intention that the teacher should know all the activities regarding continuous internal evaluation process the academic calendar is prepared.

The students' academic progress is monitored regularly through continuous internal evaluation, seminars, unit test, tutorials, project works and semester examination. The academic calendar also includes the dates of commencement and completion of syllabus, it specifies the tentative dates of semester examination. The performance of the student is assessed by conducting test examinations as per the norms and regulations of Dr. B.A.M. University Aurangabad. Besides these tests, projects, quiz, seminar, group discussion, tutorials, assignment are also the part of continuous Internal Evaluation.

Gender Sensitization

The growing importance of gender equality is communicated effectively to the students through these courses. The institution arranged a quiz competition as a part of gender sensitization programme. Women empowerment and gender equity is inculcated among the students through different activity conducted by NSS and cultural committee of the college. Every year we observe international women's Day on 8th March, A special health- check up camp and HB detection camp is organized for girl students and Women staff members. We have ladies' common room and well- equipped wash room for girl students. There is reading section for girls in Library. The students are informed about the rules and regulations about that. The institute established Anti Ragging committee, Sexual Harassment Prevention Cell, Discipline Committee, Grievance Redressal Cell etc. to sensitize the students and employees on gender issue and make them aware of the social, moral and legal implication of gender discrimination. Gender related cross cutting issues are also reflected in the university curriculum of Sociology (BA), Hindi (BA) Zoology, (B.Sc.) and Political science (BA). The college maintain an environment which is free of gender discrimination.

Professional ethics: A special code of conduct is prepared by institution for stakeholders. Details of the term are reflected in curriculum of Economics (BA) History (BA) Political science. In the institute we observe professional ethics throughout teaching- learning, research and student admission, staff recruitment and implementation of Government and University policies. Professional ethics are taught to students as a part of their holistic development.

3. Environment and Sustainability:

Institution has also its green and environment policy. The importance of our ecosystem is also highlighted through the related topic in Chemistry, Botany, Zoology and Physics. On second October we organize cleanliness drive with the help of NSS volunteers. For second year students Environment science is a compulsory subject offered by University. Through the topics of Chemistry, Botany, Zoology and Physics students can get understanding of our ecosystem, natural resources, bio-diversity, pollution due to various factors. Environmental protection policy acts is also included in the syllabi to make the students fully aware and responsive about environment. The institute have separate waste management system for solid, liquid and e-waste in the campus. We have rainwater harvesting system. In the University curriculum of Commerce, Chemistry, Zoology, and Botany sustainability related cross-cutting issues are included.

Through the NSS unit institution promotes environmental protection through tree plantation and other

sustainable development programmes. NSS students participate in tree plantation and cleanliness programs. Through these program students get awareness about the 'importance of preservation of the environment'. Every year NSS unit undertakes host of activities in the nearby village.

2.3 Teaching- Learning Process

2.3.1 Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences and teachers use ICT- enabled tools including online resources for effective teaching and learning process

Response:

Our college always encourage student-centric learning through various methods such as group discussion, quiz competitions and presentations, as students are said to be the most important factor in teaching-learning process. All stakeholders are important but we focus on students as an important stakeholder. In entire teaching on program an attempt is made to involve the student in the class seminar, group-discussion, test- tutorials and other co-curricular as well as extra- curricular activities. Subject related home

assignments and tutorials are given. Activities like students-seminar, MCQ, discussion, preparing wallpapers, group discussions, yoga practice are performed. In order to develop new ways of thinking Learning resources like educational videos are provided. The platform is given to students through associations in various subjects like science commerce, language, social Science for experience and participative learning. Students are encouraged to participate in the conference organized for teachers. N.S.S. Unit organizes special camp to increase awareness of students regarding social issues and extension activities. Our college students are given coaching and training for various tournaments and matches. Our college student participates in research festival Avishkar. In this research festival the college organizes the presentation of the students before University. Due to this experimental learning competency level of students are enhanced. Various programs throughout the year help to enrich students' cultural competencies. Students village survey through NSS camp and study tour helps to increase academic experimental learning of the students. Students representative are nominated on IQAC and other committees of college. Our placement cell train the students for interview and organize different placement camps.

The students are also encouraged to participate in different seminars at another Institute. Practicals of science department are conducted through experimental learning. Department of Commerce, History, English, Hindi organizes Study- tour and field visits. Collaboration and MOUs are made with various institutions and industries. Research projects are prepared by BA students as part of University curriculum every year. The institute run certificate courses along with University curriculum. These courses help us to know effective student centric methods.

Faculty members of the institution use ICT technology to improve the teaching and learning process, YouTube video, WhatsApp group, Telegram, Zoom and Google classrooms are used to teach, communicate, provide study materials and syllabus, making announcements, conduct tests, upload assignments and to make presentations. These applications are also used to provide online education during the Covid-19 situation, besides conventional lecture method. Teachers make their own PPT presentation regarding their subjects. The study material is also posted in the WhatsApp groups for the benefits of the students. This makes the process of teaching learning effectively. Group- Discussion and seminar also promote to student for asking questions. In order to develop critical thinking, creativity and scientific temper among students and different practices are adopted in the college. Participation in research festival Avishkar and other competitions are participated for increasing critical thinking and scientific temper. Educational and study tours and field visits are also arranged. Through subject association students are encouraged to prepare wallpaper on different scientific and literary topics.

2.5 Evaluation Process and Reforms

2.5.1 Mechanism of internal/ external assessment is transparent and the grievance redressal system

is time- bound and efficient

Response:

The department undertake class tests and internal examination before the commencement of semester University examination as part of continuous internal evaluation. The mechanism of internal assessment is transparent and robust in our college. As our Institute follows the rules and regulations of Dr. Babasaheb Ambedkar Marathwada University, Aurangabad. So, the college prepare an Academic calendar according to the university rules and regulations. The academic calendar specifies the internal exam conduction twice a year. The department also measures the academic progress of the students through presentation (PPT), group discussions, home assignments, project making and class tests. Faculty members are involved in the process of question paper setting, question paper evolution. Question papers are prepared taking into consideration the syllabi prescribed by University and portion covered in the classroom.

In this way the students are allowed to access their own work and any modifications to the marks are reflected. The feedback on the students' performance helps the student to perform better for the next year. Academic feedback system helps us determine the capacity of accepting by students. For internal assessment pattern like written examination, assignments, seminar and group discussion, students are informed in advance. The departments display time table on notice board and posted to student's WhatsApp groups. Projects are allotted to students and students complete the projects in stipulated time, for T.Y. B.A. project work is made for 100 marks. These projects are submitted to respective departments. Internal assessment is also meant for Science and Commerce faculty in practical work concerned subject teachers assess the project with one external expert.

We run the institution keeping students at the center, to deal with examination related grievances, there is a mechanism in our college. The grievances of students regarding the assessment and evaluation process are resolved in steps, first at the institute level and then university level depending upon the nature and intensity of the grievance. The college level grievances are redressed by the concerned Head of the Departments and the university level grievances are redressed by examination section of University with guidelines of the Principal and the office superintendent. Students are allowed to ask for photocopies of answer sheets on the fixed payment prescribed by affiliating University in case of evaluation redressal. The students are also allowed to ask for revaluation of answer sheets within fifteen days after the declaration of result. After the university results notice regarding the schedule of reaching of Marks, demand of photocopy of answer books and revolution of answer books are displayed on the notice board. If there are grievances regarding the internal exam, it is redressed efficiently in time. The faculty show evaluated internal examination answer papers to the students in order to make the examination and the evaluation system transparent. Grievances of the students regarding University examinations are forwarded to the university efficiently in time.

Program outcomes and course outcomes are what the students are expected to achieve at the end of the program of course. The institutional purpose is to offer education to the students to promote them with subject knowledge and make them aware about needs of the society and to utilize their knowledge for the welfare of the community programme and course outcomes are nothing but the knowledge, skills and reasoning and scientific ability that students are expected to aquarium at the end of the course or programme. While prescribing the syllabi, the board of studies designed the POs and COs. These POS and COs are displayed on the website and also communicated to the affiliated college through circulars along with the syllabi. As our college is affiliated to Dr. Babasaheb Ambedkar Marathwada University we have accepted all the programmes offered for UG. The syllabi is made available on the website and also communicate them to the teachers and students through notice. In order to convey teachers what knowledge and skills they are expected to learn. At the first lecture of the class the concerned teachers discuss the course outcomes and give them a brief idea about the topics to be covered during the semester and give them a list of reference books that they need to refer. The students are also informed about the possible career opportunities after graduation and post-graduation.

The outcome based education and performance oriented approach has been adopted by the university and its affiliated colleges. Keeping the quality enhancement and improvement of the syllabus is framed in the meetings of Board of Studies at the University level. The same was displayed in the University website. The institution has displayed the program outcomes and course outcomes on the college website. These are formulated keeping in mind the syllabi and future career opportunity for student's program and course outcomes are closely related to the content of the syllabus. Faculty and Students were aware of program and course outcomes. Faculty wise each subjects program outcomes are uploaded in the college website for all the stakeholders.

The academic progress of the students is regularly monitored by subject teachers and Heads of Departments for effective program outcomes and attainment. The Programmes outcomes are also measured through the performance of the students in the role they play in the various activities they get involved in curricular, Co-curricular and extracurricular activities through their departments, NSS, Avishkar, Cultural and different committees.

As the attainment of Program Outcomes and Course Outcomes is the foundation on which higher educational institute rests. So, it is necessary to make a review of the accomplishment of POs and COs. In order to evaluate the attainment of POs and COs the formative and summative evaluation methods have been used. The formative evaluation system is a part of CIE through which students are evaluated continuously to see whether the program/ Course Outcomes are attained or not. The formative evaluation system consists of home assignments, Study tour, Students Seminar, Field Projects, industrial Visits etc. On the other hand, the summative evaluating system consists of semester wise examinations conducted by the university with the help of college administration at the end of each semester. The unique feature of the mechanism is that there is an excellent blending of subjective observation and objective assessment of the students' performance. For these desired outcomes, the college first organizes.Various activities to get outcomes and then does its evaluation by various ways. The result analysis and attainment of programme Outcome is discussed in the IQAC meeting.

As a part of continuous evaluation, the assessment of student's performance is conducted through Home Assignments, Unit test, seminars and group discussions. It is very essential to take a review of the accomplishment of POs and COs as the attainment of programme outcomes and course outcomes on which higher educational institution rests. The performance of the student in University examination is the source to judge their assessments. Other aspects of outcomes are evaluated indirectly through their performance such as active involvement in curricular, extra- curricular activities, sports, cultural, debate, elocution and NSS program. The teachers also access the development of students and their performance through observation, the participation of the students in departmental activities, study tour, industrial visits etc. also help for the assessment of students.

The Summartive evaluation system consists of semester wise examinations conducted by the University with the help of college administration at the end of each semester. The University Assessment consists of 100 marks for Science and Arts Degree and 80 marks for Commerce Degree i.e. 80% of total marks. The choice-based credit system has been implemented for B.Com. course. Science faculty students are assessed based on their performance in the practical examinations as well as written examinations conducted by the University. CGPA (cumulative grade point average) grading system has been used to measure overall academic performance of a students. The formative evolution system is a part of CIE through which students are evaluated continuously to see whether the program/course outcomes are attained or not.

Institute has playgrounds as volley ball and kabaddi, Kho-Kho and athletic events.

• Classrooms-

There are 15 classrooms. Out of them one classroom is ICT enabled and two smart classroom and adequate infrastructural facilities to facilitate effective teaching and learning for future development. Special care is taken that all classrooms have proper physical facilities like Benches, Boards, lights etc. The institution has a sufficient number of well furnished, electricity-efficient, well-ventilated and specious classrooms for conflicting theory classes.

• Laboratories -

In all, there are 3 Laboratories for Physics, Chemistry, Botany and Zoology. Botany and Zoology laboratory has ICT facility. There is one computer lab with LAN which helps students for learning process. Laboratories are well equipped and well maintained for carrying out curriculum-oriented lab Practicals. The computer lab is equipped with servers, computers, internet connectivity, Printer and scanner.

• Library -

The college has adequate library space of 158 sqm. Consists of 11362 books and separate reading space for boys, girls and faculties. There are separate reading rooms and study sections for girl and Boy students. Study material available in the library is as follows: Textbook- 11035 Reference Books- 327, Magazine-29.

• IT Infrastructure-

There are 27 computers with updated versions. They help students and teachers to develop their software knowledge. Internet and wi-fi facilities are available. The institute has sufficient space for all academic, administrative co-curricular and extra-curricular activities. Institute is well equipped with classrooms, laboratories. IQAC office with two PC and internet connection, Printer & scanner.

Institute has equipment's like 02 LCD Projectors, 02 interactive board, 07 Printers attached with PCs where necessary, scanners for office and IQAC work, 01 Invertor, Xerox machine for office work, faculty members, examination work, department work for students and IQAC, Drinking water tank with filter and cooler available for students and faculty members, CCTV for security purpose installed in office, library, staff room, IQAC office & college premises.

6.3 Faculty Empowerment Strategies

The institute has a system for assessment of yearly performance of the teaching and non- teaching staff. Institute has established API committee.
